Description

Type of offer

In principle, requests for residue data of pesticides and contaminants in relation to different parameters can be processed. These parameters can be:

- Product type: product group (according to Annex I of Regulation (EC) No. 396/2005) or specific products (e.g. apples, carrots, cereals such as wheat, oilseeds such as soya or rape, etc.)
- Type of cultivation: conventional or organic
- Origin: country-specific (e.g. Germany)
- Period (limited to a maximum of 3 years)
- Analytes: selected pesticides or contaminants or general overview of the detection of pesticides or contaminants by multi-method, group or individual methods
- Results: positive findings (only TOP-10 pesticides in the case of multi-methods) including information on detected levels < reporting limit (< RL) plus number of data sets

Data from special projects (e.g. from pre-harvest samples or cross-checks) as well as from processed products are generally not part of the data queries.

The provision of the data is carried out by the laboratories (at least 2 laboratories per query) to Lach & Bruns / relana[®] in Excel format according to the specifications of Lach & Bruns and the customer's requirements.

Lach & Bruns structures the data and prepares them according to the customer requirements.
